Increasingly, with the financial pressure to ensure that we can balance the budget, we are left unable to pursue investment that we would love our young learners to have access to. As such, we have decided to draw up a wish list that we would like to use the School Fund towards. Every item is for the benefit of our learners (in order of priority).

Gym equipment for a new gym space behind the new PE changing rooms:	£8,000
Seating areas for learners in outdoor spaces:	£2,000
Outdoor sports equipment (table tennis tables, basketball hoop integrated systems...):	£4,000
New dining tables and seating :	£10,000
Digital clock for display on the school yard:	£1,000

We have listened to learners' suggestions for this wish list, and are happy to listen to any further suggestions. However, they must benefit the large number of the student body and enhance their time while at St John Fisher Catholic College. In order to try and tick off any items on this wish list, we are asking every family to pay into the School Fund. As soon as we have funding for the different projects, we will begin them. To help raise the additional funding that we need this year we are asking for a £30 school fund donation for families with one child attending the school and £50 from families with more than one child.
